Delhi MLA Alka Lamba quits AAP, says 'time to say good bye'

Aam Aadmi Party's Chandini Chowk legislator Alka Lamba quit the party with a 'time to say goodbye message', capping months of differences with the leadership that often played out on social media platforms. She is expected to go back to the Congress, the party with which she started her political career in 1994.
"The time has come to say "Good Bye" to #AAP and to resign from the primary membership of the Party. The past 6 years journey was a great learning for me. Thanks to all," the 43-year-old leader tweeted.
Lamba's resignation comes days after she met Congress president Sonia



Gandhi to discuss 'current affairs'. "Discussion with Smt Sonia Gandhi on current affairs was long due. Today, got a chance to discuss all issues with her. In politics, such interactions have been going on and must continue."
She tweeted after the September 3 meeting.
The MLA, who has been at loggerheads with the party leadership for some time, had on August 4 announced that she would quit the AAP. Responding to which

AAP spokesperson Saurabh Bhardwaj had tweeted, "She has announced this a dozen of times in the past. It takes 1 min to send a written resignation letter to party leadership. We will accept it on Twitter too." This was followed by a bitter Twitter spat between the two.

Lamba has often spoken about being 'disrespected' by the party and has had social media spats with party leaders on several occasions. After the AAP's defeat in the Lok Sabha polls, she had sought accountability from party chief Arvind Kejriwal following which she was removed from the official WhatsApp group of the lawmakers. In the run-up to the Lok Sabha elections, Lamba had refused to

campaign and also kept away from Kejriwal's roadshow after she was asked to walk behind his car during the event.

Her first skirmish with the party leaders was over the AAP's decision to pass a resolution to revoke Rajiv Gandhi's Bharat Ratna over his comments on the 1984 anti-Sikh riots. Lamba had raised objections to the move and said that she was ready to face any punishment because of her actions. After her stint as a student leader, that started in 1994, Lamba was appointed the general secretary of All India Mahila Congress in 2002. In 2003, she unsuccessfully contested Delhi Assembly elections from Moti Nagar Constituency against senior BJP.

Delhi, Mumbai fall in Liveability Index, brought down by air quality, culture downgrade

Indian cities have not fared too well in the Economist Intelligence Unit's Global Liveability Index for 2019, released Wednesday, with both Delhi and Mumbai sliding down ranks relative to last year.

The EIU's index ranks cities by five headline criteria. Stability and culture & environment are the two most important categories, weighted equally at 25% of the total. Healthcare and infrastructure are also matched at 20%, with education coming in last with a 10% weighting.

New Delhi dropped six places to 118, from 112 last year, as there's been an increase in petty crime cases over the past year, as well as recording some of the world's



worst air quality levels, the report says. Mumbai also fell in this year's index, by two places to 119, from 117

last year, as a result of a downgrade in its culture category.

"Few cities in Asia have

seen major changes to their score over the past year, with the exceptions of Colombo, which has seen its stability

score fall following the Easter Sunday bombings in 2019, and New Delhi, which dropped six places in the ranking relative to last year. The Indian capital has seen an increase in petty crime cases over the past year, as well as recording some of the world's worst air quality levels. The 2018 update to the World Health Organisation (WHO) Global Ambient Air Quality Database shows that New Delhi currently boasts the sixth highest annual mean concentration of fine particulate matter among cities around the world," the report states.

Another Asian city Dhaka Dhaka remains the third lowest ranked city in the index, and the weakest performer in Asia. Port Moresby in Papua New Guinea (135th, 41) and Karachi in Pakistan

(136th, 40.9) are the other two Asian cities that appear in the bottom ten cities in the ranking.

"Reflecting the diversity of Asia, these cities all have fairly different characteristics. Dhaka is relatively stable but has very poor health provision and outcomes, and very weak infrastructure. Karachi has very high crime rates and gang violence, but education is considered fairly strong and its infrastructure score is passable," the report adds.

Among the toppers are Vienna and Melbourne who have been neck and neck in the EIU survey for years, but the Austrian capital also regularly tops a larger ranking of cities by quality of life compiled by consulting firm Mercer.

Delhi man fined ₹ 16,000 for drunk driving, sets his motorcycle on fire

Furious over being challaned Rs 16,000 by the traffic police for driving drunk, not carrying any registration document and not wearing a helmet, a man set his two-wheeler on fire in south Delhi's Chirag Delhi on Thursday evening.

Additional deputy commissioner of police (south) Parvinder Singh said they received a call at Malviya Nagar police station reporting that a motorcycle has been set on fire in Triveni Complex, Chirag Delhi.

"When a police team reached the spot, it was found that a team of Delhi traffic police was carrying out a checking against drunk driving. The traffic police staff told us that they had hailed one motorcycle rider who was driving without helmet. He was identified as Rakesh, a resident of Sarvodaya Enclave, who works at a restaurant in Hauz Khas. He was also drunk," Singh said.

The traffic police officials asked him to show the

documents of the vehicle. "They said he could not produce a valid registration document of the bike. Since he was also drunk and was not wearing a helmet, the policemen issued a challan (fine) accordingly," Singh said.

As per the new law, Rakesh was slapped with a fine of Rs16,000 — Rs 10,000 for drunk driving, Rs 5,000 for driving without registration documents and Rs 1,000 for riding a two-wheeler without helmet.

Another police officer said, after issuing the fine, when the traffic police were impounding the man's motorcycle he got furious. "Initially, he resisted and

then kicked his motorcycle. As the vehicle fell on the road, he pulled its fuel pipe, spilling the petrol. Before the policemen could control him, he took out a matchbox and set the bike on fire," the officer said requesting anonymity.

The man was overpowered by the police team and was later taken to Malviya Nagar police station and a case was registered against him.

Though the amended Motor Vehicles Act was implemented across the country on September 1, Delhi is still waiting for a notification from the Delhi government which will clarify the details of 'compounding.

On the basis of his statement and medical report, a case of assault or criminal force to deter public servant from discharge of his duty, voluntarily causing hurt to deter public servant from his duty and obstructing public servant in discharge of public functions has been registered," said a senior police officer. North corporation mayor Avtar Singh, said, "We strongly condemn any assault on our MCD inspector. Our sanitation staff works from 6 in the morning till late in the evening. There could be some shortcomings in their work but that is no reason to get physical. This is obstructing a government servant from discharging his duty and Akhilesh must be given the strongest punishment in accordance with law."

Odisha conjoined twins ready to return home after 2 years

VR technology, 3D printing, countless hours of planning, dry runs, two day-long surgeries, a new circulatory system for the brain, kidney malfunction, cardiac arrest, heartache, hope, grit and prayers. That's what it took a team of multidisciplinary medical staffers at the All India Institute of Medical Science (AIIMS) in New Delhi to successfully separate a pair of craniopagus conjoined twins—Jangannath (Jagga) and Balram (Balra)—over two years.



Today, they're finally ready to go home, Odisha. While Jagga is "like any other normal child", Balra still cannot speak and would need prolonged rehabilitation, doctors said. "He will get better over the years, but Balra is unlikely to be 100% normal, ever. How can we even expect that? The brains of the both the children were never fully formed. Luckily for Jagga, he had a proper blood circulation in the brain. We had to put in a venous graft for Balra to maintain blood supply. Even then some parts of his brain are likely to atrophy or die off," Dr Deepak Gupta, who headed the surgical team and is a paediatric neurosurgeon at AIIMS-Delhi, said, adding that when they had first come to the hospital in July 2017, not only were their skulls connected, their brains were also fused and shared the circulatory system. Jagga and Balra are the first pair of craniopagus twins, or twins conjoined at the head, to have survived a separation surgery in India.

चांदनी चौक से आप विधायक लांबा ने पिछले महीने घोषणा की थी कि उन्होंने पार्टी छोड़ने और आगामी विधानसभा चुनाव निर्दलीय के रूप में लड़ने का मन बना लिया है।

उल्लेखनीय है कि लांबा पिछले कुछ समय से आप नेतृत्व खासकर पार्टी के मुखिया और दिल्ली के मुख्यमंत्री अरविंद केजरीवाल की कार्यशैली से नाराज चल रही थीं। केजरीवाल पर पार्टी में मनमानी करने का आरोप लगते हुए वह इसका सार्वजनिक तौर पर कई बार मुखर विरोध कर चुकी है। अलका लांबा और आम आदमी पार्टी के बीच पिछले कुछ समय से टकराव की स्थिति जो शुरू हुई, वह किसी न किसी रूप में चलती रही है।

10वीं की छात्रा ने चलाया बुलेट तो दो लोगों से मिली ये धमकी

दिल्ली के करीब 50 किमी दूर गांव मिलक खटाना में बाइक चलाने पर 10वीं की छात्रा को धमकाने का मामला सामने आया है। हिन्दुस्तान टाइम्स की रिपोर्ट के अनुसार, दो लोग उनके घर में घुसे और कहा कि लड़की बाइक न चलाए। इतना ही नहीं आरोपियों ने हवा में फायर करते हुए धमकी भी दी। छात्रा ने जब पूछा कि वह बाइक क्यों न चलाए तो आरोपियों ने कहा कि उसका मोटरसाइकिल चलाना उन्हें पसंद नहीं है। घटना 31 अगस्त की है। शिकायत मिलने पर पुलिस ने आरोपियों सचिन व कल्लू के खिलाफ एक सितंबर को मामला दर्ज कर लिया। आरोपियों के खिलाफ धारा 506(अपराधिक धमकी) धारा 504(जानबूझ कर अपमान करना और शांति भंग करना), धारा 323 (किसी को चोट पहुंचाना) और धारा 452(किसी के घर में घुसना) तहत मामला दर्ज किया है। हालांकि पुलिस ने अभी तक किसी को गिरफ्तार नहीं किया। छात्रा के चाचा ने बताया कि सचिन अपराधिक प्रवृत्ति का है इसलिए उन्हें सुरक्षा को लेकर डर है। पुलिस ने बताया कि घरवालों ने छात्रा की उम्र का खुलासा नहीं किया क्योंकि वह नाबालिग है। मामले की तहकीकात की जा रही है। छात्रा दादरी के एक गवर्नमेंट स्कूल में पढ़ती है। पीड़िता के चाचा के अनुसार, 31 अगस्त को वह बाजार रॉयल इन फील्ड बाइक से दूध खरीदने गई थी। आरोपियों ने रास्ते में उसकी बाइक रोकी और उसे न चलाने के लिए कहा। जज छात्रा ने इसका कारण पूछा तो आरोपियों ने कहा कि सलाह नहीं मानने पर परिणाम भुगवने को तैयार रहना। इसके बाद आरोपी युवक छात्रा के घर गए और वहां पर घरवालों को धमकाया।

शेहला रशीद पर देशद्रोह का मुकदमा दर्ज, सेना के खिलाफ झूठी खबर फैलाने का आरोप

जेएनयू की पूर्व छात्रा और कश्मीरी नेता शेहला रशीद पर दिल्ली पुलिस को स्पेशल सेल ने देशद्रोह का मुकदमा दर्ज किया है। शेहला पर यह गंभीर आरोप है कि उसने भारतीय सेना कि खिलाफ झूठी खबर फैलाई है। पुलिस ने शुक्रवार को कहा कि इन ट्वीट में उन्होंने आरोप लगाया था कि जम्मू-कश्मीर का विशेष दर्जा वापस लिए जाने के बाद सशस्त्र बलों ने घाटी में आम नागरिकों को 'प्रताड़ित किया और घरों में तोड़फोड़ की। पुलिस ने बताया कि उन पर भारतीय सेना की छवि धूमिल करने की मंशा से फर्जी खबरें फैलाने का भी आरोप लगाया गया है। रशीद ने 17 अगस्त को एक के बाद एक कई ट्वीट कर आरोप लगाया कि कश्मीर में सशस्त्र बल रात में घरों में घुसे और उनमें हॉइड्रोड्रॉम की। साथ ही उन्होंने आरोप लगाया था कि चार लोगों को शोपियां में सेन्य शिविर में बुलाया गया और उनसे पूछताछ (प्रताड़ना) की गई। बाद में, उच्चतम न्यायालय के अधिवक्ता अलख अलोक श्रीवास्तव ने दिल्ली पुलिस आयुक्त अमूल्य पटनायक के पास यह कहते हुए शिकायत दर्ज कराई कि जेएनयू की पूर्व छात्र नेता के आरोप पूरी तरह गलत और मनगढ़ंत हैं। पुलिस ने कहा कि शिकायत मिलने के बाद इसे जांच के लिए दिल्ली पुलिस के विशेष प्रकोष्ठ को सौंप दिया गया। रशीद पर भारतीय दंड संहिता (बादर्स) की धारा 124ए (राजद्रोह) के तहत मामला दर्ज किया गया है। पुलिस ने बताया कि यह मामला तीन सितंबर को दर्ज किया गया।
